## A Message from the Chair

2023 has been another impactful and productive year at the McKell Institute.

After a strong start to the year, former CEO Michael Buckland departed the Institute for a senior role within the NSW Government.

We thank Michael Buckland for his service to the McKell Institute. For two years, Michael navigated the challenges of COVID-19 skilfully, leaving the Institute in a stronger position than before the pandemic. We wish him well in his new role.

In June, the McKell Institute board appointed long-serving McKell Institute staff member Ed Cavanough to the role of CEO. Since, we have continued to host meaningful dialogues with key decision makers, and undertake research focused on identifying practical, real-world solutions to the issues facing everyday Australians.

We're encouraged that this year, we have seen numerous McKell Institute proposals shape government policy.

Our wage theft, labour-hire reform, Free TAFE and community battery proposals are now Albanese Government policy. At state levels, we have seen governments in Queensland, New South Wales and Victoria adopt McKell Institute ideas on issues as diverse as manufacturing, skills & training, and the provision of mental health services.

These achievements are detailed in this year's *Impact Statement* and reflect the Institute's focus on translating practical policy ideas into real-world outcomes.

As we look toward 2024, we see an increasingly complicated set of policy challenges facing governments across Australia.

In the near term, cost of living pressures, exacerbated by increasing interest rates and rising rents, are testing Australian households.

Meanwhile, the international environment is becoming more complex, straining global supply chains, increasing the price of essentials such as fuel, and placing additional demands on government.

Amid this context, the Albanese Government has passed the half-way point of its first term, and the conversation will soon shift towards a second-term agenda.

The McKell Institute looks forward to playing a constructive and impactful role in 2024.

# CEO Statement: A Year of Transition, Growth & Impact

After a busy run up to the state election in New South Wales, former CEO Michael Buckland departed the Institute in April for a senior role in the new Minns Labor Government.

Michael ushered the organisation through a challenging period, as COVID-19 lockdowns changed the way we all worked and did business.

That we emerged stronger on the other side of the COVID-19 restrictions is testament to Michael's leadership. McKell's loss has truly been the NSW people's gain.

After being appointed Acting CEO upon Michael's departure, I was honoured to receive the board's endorsement in June to undertake the role in an ongoing capacity.

Since then, we have been busy continuing the Institute's program of research, events and advocacy, while also building our team and expanding our network right across the country.

I am proud to lead the McKell Institute because our mission is not just to talk about issues but to solve real-world problems.

This year's annual report includes the McKell Institute's inaugural *Impact Statement*, which details the efficacy of this approach.

In it, we highlight 10 McKell Institute policies we're proud to see being put into action.

In Canberra, we have seen the Albanese Government work to close labour hire loopholes, pursue gig work reform and crack down on wage theft.

This comes after the commencement of the rollout of community batteries and free TAFE policies — ideas advanced in McKell reports prior to the 2022 Federal Election.

And at a state level, our impact has been similarly forceful.

The Minns Government's action on toll road relief, housing and homelessness, retail violence, and domestic manufacturing mirror proposals we have championed.

The Palaszczuk Government's decision to adequately fund the essential service of *Lifeline* came on the back of our advocacy.

In Victoria, we welcomed the Andrews Government's plan to boost apprenticeship completion rates, an outcome championed by the Institute in partnership with the Victorian Trades Hall Council.

The McKell Institute is also a forum for lively debate, discussion and innovative new ideas.

This year we held more than 30 events across New South Wales, Victoria and Queensland.

We heard from a bipartisan roster of premiers, treasurers, state and federal ministers and senior opposition figures, as well as senior public servants, agency leaders and other influential guests.

Particularly poignant was the sobering address from Ukrainian Ambassador Vasyl Myroschnychenko, detailing the ongoing conflict in Ukraine, and how Australia can continue to show solidarity with Kiev as Russia's senseless assault continues.

I want to thank every McKell Institute sponsor for their ongoing support, and everyone who has taken the time to reach out this year since I assumed the CEO role. McKell is bettered by its partnerships across civil society, the trade union movement and corporate Australia, and it has been a joy to get to know and work with so many of you since June.

Next year will again be a big year in Australian public policy.

The ACT and Queensland governments will go to the polls in October, while governments and oppositions in Tasmania, Western Australia and at the Commonwealth level will be considering their policy objectives ahead of elections in 2025, all amid cost-of-living pressures.

I look forward to continuing to champion practical, progressive ideas for a fairer Australia in the year ahead.

# At McKell, our focus is on producing progressive research, looking at practical solutions to existing and emerging problems.


In addition to our research, our regular events seek to bring together government ministers, senior policy makers, businesspeople and community leaders to engage with audiences on important issues.

# ED Statement

Ongoing wage theft and the cost-of-living crisis underpinned the Institute's work in Victoria throughout 2023.

*Unfinished Business: the ongoing battle against wage theft* was released in August, showing how much workers have been ripped off in every federal electorate. We'll be reminding Members of Parliament and their constituents of these worrying figures as the Commonwealth Closing the Loopholes Bill progresses in 2024.

Our spotlight on unpaid work, presented in partnership with HESTA, showed how workers across the caregiving sector are carrying an undocumented load that supports the public health system, often at the expense of their own wellbeing.

We were honoured to have Professor Emeritus Dame Marilyn Waring launch *Our place in time: making unpaid work count.* 

Other highlights included our annual Victorian budget lunch with Treasurer Tim Pallas. We hosted state and federal ministers at boardroom events to discuss health and medical research, the future of the inner city, changing workforce needs and the state's landmark housing plan.

We pushed for sophisticated solutions to housing pressures, called for a nationwide rental market overhaul, and for long-term tenancies to be protected over short-stay accommodation.

Since joining the McKell Institute earlier this year, I have been grateful for the support of the Victorian Board, chaired by Kelvyn Lavelle. Kel's enthusiasm for the Institute's Victorian branch is a key contributor to our success.

I thank previous Executive Director, Ryan Batchelor, for his dedication to progressive public policy, which has taken him to the state's Legislative Council.

Victoria's recent leadership transition from Daniel Andrews, a once in a generation political leader, to Jacinta Allan, one of the state's most experienced ministers, comes at a crucial time.

We will continue to be a pragmatic voice in complex conversations surrounding our evolving workforce, the housing market, and difficult economic conditions.

The McKell Institute Victoria heads into 2024 with a bold, progressive agenda that I look forward to delivering with our growing member base and through our political engagement, thought leadership and public advocacy.
